MEMBER REFERRAL REWARD PROGRAMME

Terms & Conditions

1. This programme is only open to Life/Ordinary Members whose names are not on the Absent Members' List, Silver, Term and Associate Members ("Referrer").
2. A Referrer who makes a successful referral will be rewarded with the appropriate F&B Credits based on the Member Referral Form which the Candidate ("Applicant") must submit, together with the application for Membership. The completed Referral Form must be signed by the Referrer and Candidate.
