

## IMPORTANT NOTES ON THE REGISTRATION OF SPOUSE AS AN ASSOCIATE MEMBER UNDER RULE 15

### Conditions

15(i) Associate Members are:

- Spouses of Honorary, Life, Ordinary, Silver or Term Members;
- Widows/widowers of deceased Honorary, Life, Ordinary, Silver or Term Members;
- Previously categorized Lady Members.

15(ii) The spouse (including in a situation of remarriage) of an Honorary, Life, Ordinary, Term or Silver Member shall automatically become an Associate Member without the payment of an entrance fee. The Member who is the spouse of such Associate Member elected under this Rule shall be liable for all such Associate Member's dues to the Club including the Associate Member's monthly subscription payable under Rule 30(i) of the Rules of the Club. Provided always that should a Member, on grounds of hardship or other cogent reason, appeal to the Committee concerning the liability to pay the Associate Member's dues to the Club, the Committee may in its sole discretion vary the provisions of this Rule in respect of the Member concerned.

15(ii)(a) It shall be the responsibility of any Honorary, Life, Ordinary, Silver or Term Member to notify the Club in writing within thirty (30) days of his or her marriage or remarriage. Where a Member fails to notify the Club, the Member shall be liable to pay his/her spouse's subscription fees, which subscription fees will be backdated to the date of such marriage or remarriage together with any other applicable charges.

### Privileges

15(v) An Associate Member shall have the same rights, privileges and obligations as an Ordinary Member, except as follows:

- (a) the right of voting at a General Meeting, but may be permitted to attend as a silent observer;
- (b) the right of election or appointment to the Committee;
- (c) the right of proposing or seconding a Candidate for admission as Member;
- (d) the right of proposing or seconding a Member for election to the Committee;
- (e) the right of proposing a resolution at a General Meeting and the right of proposing any amendment to any resolution at a General Meeting;
- (f) the right of applying to be placed on the Absent Members' List;
- (g) the right of participation in any distribution of the Club's assets;
- (h) a liability for any debts of the Club; and
- (i) the right to be involved in the governance, management and/or affairs of the Club, except for joining a Sub-Committee or Section committee, which shall be subject to approval by the Committee.
