I confirm that I meet the following criteria for eligibility under **Rule 23A** of the Membership Relinquish Scheme:

- I confirm that I meet the eligibility requirements for the Membership Relinquish Scheme as outlined in Rule 23A
- I acknowledge that, according to Rule 23A(ii), if I am an Ordinary Member whose name has been continuously on the Absent Members' List for more than 12 years, I must wait for a period of 3 years after my name is removed from the list before I can apply for this Scheme.
- I confirm that the required 3-year waiting period has passed since my name was removed from the Absent Members' List (if applicable).

EXPLANATORY NOTES – MEMBERSHIP RELINQUISH SCHEME

- 23A(i) The Club shall maintain a Membership Relinquish List to include Life and Ordinary Members who have applied to relinquish their membership.

The Waiting List established in accordance with Rule 14B(iii) shall also apply to this Scheme.

The Membership Relinquish List and the Waiting List shall operate on a *first come, first served* basis together with the Membership Conversion List established in accordance with Rule 14B. The first entry on either the Membership Relinquish List or the Membership Conversion List shall take precedence.

The Membership Relinquish List and the Waiting List shall each comprise two (2) subsidiary lists, one (1) subsidiary list in respect of Singapore citizens, and one (1) in respect of non-Singapore citizens.

Whether such a Life or Ordinary Member should be placed under the respective subsidiary list for Singapore citizens or for non-Singapore citizens shall be determined by the citizenship of the Member as at the time of the Member's election as an Ordinary Member, except for the provisions of Rule 23B.

- 23A(ii) A Life or Ordinary Member applying to relinquish said membership shall apply in writing to the Club to be placed on the Membership Relinquish List.

Notwithstanding any other provision of this Rule, an Ordinary Member whose name has been continuously on the Absent Members' List for a period exceeding twelve (12) years shall not be eligible to apply under this Scheme until a period of three (3) years has elapsed from the date on which such Member's name is removed from the Absent Members' List.

- 23A(iii) An Ordinary Member shall not be placed on the Membership Relinquish List unless the said Member's subscription under Rule 30 have been paid in full when they are due.

- 23A(iv) An Ordinary Member applying to relinquish membership of the Club under this Rule shall continue to be liable for monthly subscriptions under Rule 30 until the said membership has been relinquished.

- 23A(v) A Member who has made an application under Rule 23A(ii), but whose name is subsequently placed on the Absent Members' List or becomes in arrears of monthly subscriptions under Rule 30 shall be removed from the Membership Relinquish Scheme.

- 23A(vi) The Club shall pay sixty-seven per cent (67%) of the prevailing Ordinary Membership Entrance Fee as payment to the Life or Ordinary Member to relinquish his membership.

The Committee shall not pay a Life or Ordinary Member to relinquish membership, unless there is a confirmed Candidate to fill the Vacancy so formed by said Life or Ordinary Member's membership being relinquished.

- 23A(vii) On application by the Life or Ordinary Member to relinquish said membership, the Club shall place the membership of said Life or Ordinary Member on the Membership Relinquish List where the following conditions are met:

- (a) the Club has notified the Life or Ordinary Member in writing of the agreement to relinquish said membership; and
- (b) the Vacancy so formed, once the Member ceases to be a Member is for the purpose of satisfying the demand on the Waiting List.

23A(viii) The Life or Ordinary Member applying to relinquish said Member's membership under Rule 23A(ii) may request the Committee in writing for said Member's child or grandchild to be elected to fill the Vacancy so formed, provided that the child or grandchild is at least twenty-five (25) years of age and is on the Waiting List, and the said child or grandchild shall be given first priority on the Waiting List.

23A(ix) When there is a request pursuant to Rule 23A(viii), the Committee shall consider such request.

Where, in exercise of the Committee's discretion, the said request pursuant to this Rule 23A(ix) is approved.

- (a) the child or grandchild of the Life or Ordinary Member shall be resident in Singapore;
- (b) the child or grandchild of the Life or Ordinary Member shall pay the full prevailing Ordinary Membership Entrance Fee as prescribed under Rule 29; and
- (c) the Club shall at all times maintain the prevailing mix of Singapore citizen Members and non-Singapore citizen Members, except for the provision under Rule 23B.

23B. When there is a request pursuant to Rule 14B and 23A, the Committee shall consider such request. Where, in exercise of the Committee's discretion, a conversion or relinquishment of membership is approved, pursuant to this Rule, the Club shall at all times maintain the prevailing mix of Singapore citizen Members and non-Singapore citizen Members with the exception that in the event that the Club has been unable to procure a non-Singapore citizen Candidate to acquire Ordinary Membership to the Club after twelve (12) months of the Life or Ordinary Membership held by a non-Singapore citizen Life or Ordinary Member being on the Membership Conversion List or Membership Relinquish List, then the Committee may classify that non-Singapore citizen Life or Ordinary Membership as an "Open Category" Ordinary Membership and available for transfer to either a Singapore citizen or non-Singapore citizen Candidate
