TERMS & CONDITIONS

- (1) I understand that it is my responsibility to inform the Tanglin Club as soon as is practical of any changes to my personal particulars or circumstances as set out in this application form.
- (2) I understand that a Silver Member shall not be entitled to the Membership Relinquish Scheme when he or she resigns his or her Silver Membership.
- (3) As a Silver Member, I acknowledge and agree that I shall have the same rights, privileges and obligations as an Ordinary Member, except as follows:
 - a) the right of voting at a General Meeting, but may be permitted to attend as a silent observer;
 - b) the right of election or appointment to the Committee;
 - c) the right of proposing or seconding a Candidate for admission as Member;
 - d) the right of proposing or seconding a Member for election to the Committee;
 - e) the right of proposing a resolution at a General Meeting and the right of proposing any amendment to any resolution at a General Meeting;
 - f) the right of applying to be placed on the Absent Members' List;
 - g) the right of participation in any distribution of the Club's assets;
 - h) a liability for any debts of the Club;- and
 - i) the right to be involved in the governance, management and/or affairs of the Club, except for joining a Sub-Committee or Section committee, which shall be subject to approval by the Committee.
- (4) I further acknowledge and agree that the right, privileges and obligations of a Silver Member may be amended or varied by resolution passed at a General Meeting, and that any such amendments or variations shall be binding and shall apply to me in accordance with the Rules of the Club in force at the relevant time.
- (5) I acknowledge and understand that the Committee shall not convert a Life or Ordinary Member, who is qualified under Rule 14B(ii) to Silver Member, until there is a confirmed Candidate to fill the Vacancy so formed by the said Life or Ordinary Member's conversion to Silver Membership.
- (6) I acknowledge and understand Rule 14B(iii), which states that the Membership Conversion List and the Waiting List, shall operate on a first come, first served basis together with the Membership Relinquish List, with the exception as outlined in Rule 23B.
- (7) I acknowledge and understand that an Ordinary Member applying for Silver Membership shall continue to be liable for monthly subscriptions under Rule 30 until the membership class of that Member has been converted to that of a Silver Member.
- (8) I acknowledge and understand Rule 23B, which states that, with the approval of the General Committee, non-Singaporean applications on the waitlist that have been awaiting a buyer for 12 months and the Club has been unable to procure a non-Singaporean Candidate to acquire Ordinary Membership, will be classified as an "Open Category" and available for transfer to either a Singapore citizen or non-Singapore citizen Candidate.
- (9) I acknowledge and confirm that I have read the explanatory noted on this form, and I fully understood and agree to comply with the terms and conditions governing the application under the Membership Conversion Scheme.

EXPLANATORY NOTES – SILVER MEMBERS (RULE 14B)

- 14B(i) A Silver Member is a Life or Ordinary Member who has been converted to Silver Member by the Committee in accordance with the provisions of the Rules and has been paid by the Club a sum equal to fifty-seven per cent (57%) of the prevailing Entrance Fee for Ordinary Membership.

The Committee shall not convert a Life or Ordinary Member, who is qualified under Rule 14B(ii) to Silver Member, until there is a confirmed Candidate to fill the Vacancy so formed by the said Life or Ordinary Member's conversion to Silver Membership.

Qualification

- 14B(ii) Only a Life or Ordinary Member who:
- has been a Life and/or Ordinary Member for a minimum continuous period of twenty (20) years as from the date of his election as an Ordinary Member;
 - is aged seventy-five (75) years or above;
 - who has applied for conversion to Silver Membership; and
 - whose name is on the Membership Conversion List; and;
 - who, if he or she whose name has at any time been on the Absent Members' List, has ceased to be on such list for a continuous period of at least (3) years as returned Ordinary Member immediately prior to the application for conversion, shall be eligible to the conversion of his or her Life or Ordinary Membership to Silver Membership

Membership Conversion Scheme

- 14B(iii) The Club shall maintain a Membership Conversion List to include Life and Ordinary Members who qualify in accordance with Rule 14B(ii)(a) to (d) and who have applied to convert their membership category to be a Silver Member.

The Club shall also maintain a Waiting List in respect of Candidates who have applied to be elected as Ordinary Members and have been proposed for membership to the Club.

The Membership Conversion List and the Waiting List shall operate on a *first come, first served* basis together with the Membership Relinquish List at Rule 23A. The first entry on either the Membership Conversion List or the Membership Relinquish List shall take precedence.

The Membership Conversion List and the Waiting List shall each comprise two (2) subsidiary lists, one (1) subsidiary list in respect of Singapore citizens, and one (1) in respect of non-Singapore citizens.

Whether such a Life or Ordinary Member should be placed under the respective subsidiary list for Singapore citizens or non-Singapore citizens shall be determined by the citizenship of the Member at the time of the Member's election as an Ordinary Member, except for the provisions of Rule 23B.

- 14B(iv) The Life or Ordinary Member applying to convert said Member's membership under Rule 14B(i), (ii) and (iii) may request the Committee in writing for said Member's child or grandchild to be elected to fill the Vacancy so formed, provided that the child or grandchild is at least twenty-five (25) years of age and is on the Waiting List, and the said child or grandchild shall be given first priority on the Waiting List.

- 14B(v) When there is a request pursuant to Rule 14B(iv), the Committee shall consider such request at its discretion, subject to the following conditions:

Where, in exercise of the Committee's discretion, the said request pursuant to this Rule 14B(v) is approved:

- (a) the child or grandchild of the Life or Ordinary Member shall be resident in Singapore;
- (b) the child or grandchild of the Life or Ordinary Member shall pay the full prevailing Ordinary Membership Entrance Fee as prescribed under Rule 29; and
- (c) the Club shall at all times maintain the prevailing mix of Singapore citizen Members and non-Singapore citizen Members, except for the provision under Rule 23B.

Rights

- 14B(vi) A Silver Member shall have the same rights, privileges and obligations as an Ordinary Member, except as follows:

- (a) the right of voting at a General Meeting, but may be permitted to attend as a silent observer;
- (b) the right of election or appointment to the Committee;
- (c) the right of proposing or seconding a Candidate for admission as Member;
- (d) the right of proposing or seconding a Member for election to the Committee;
- (e) the right of proposing a resolution at a General Meeting and the right of proposing any amendment to any resolution at a General Meeting;
- (f) the right of applying to be placed on the Absent Members' List;
- (g) the right of participation in any distribution of the Club's assets;
- (h) a liability for any debts of the Club; and
- (i) the right to be involved in the governance, management and/or affairs of the Club, except for joining a Sub-Committee or Section committee, which shall be subject to approval by the Committee.

Conversion Fee

- 14B(vii) A Life or Ordinary Member applying to convert said membership shall apply in writing to the Club to convert his membership to Silver Membership and his name shall be placed on the Membership Conversion List.

An Ordinary Member shall not be placed on the Membership Conversion List unless the said Member's subscriptions under Rule 30 for the preceding twelve (12) months have been paid in full when they are due.

An Ordinary Member applying for Silver Membership shall continue to be liable for monthly subscriptions under Rule 30 until the membership class of that Member has been converted to that of a Silver Member.

A Member who has made an application under this Rule 14B(vii), but is subsequently placed on the Absent Members' List or becomes in arrears of monthly subscriptions under Rule 30 shall be removed from the Membership Conversion Scheme.

A Silver Member shall not be entitled to the Membership Relinquish Scheme.



Silver Associates

14B(viii) An Associate Member of a Silver Member shall have the same rights and privileges as that for an Associate Member of an Ordinary Member, except the Associate Member of a Silver Member shall not be eligible to apply to convert Associate Membership to Ordinary Membership or permitted to attend a General Meeting.

Limit on Silver Memberships

14B(ix) The number of Silver Memberships shall be limited to a maximum of 20% of Planned Total Membership.
